NO PURCHASE NECESSARY

ELIGIBILITY

Open to legal residents of the United States who are 18 years of age or older at the time of entry. Employees of Florida Credit Union (FCU), its affiliates*, and immediate family members are not eligible to participate. By entering, participants certify that they meet these eligibility requirements.

ENTRY PERIOD

The entry period for each giveaway will be clearly stated in the associated social media post, including the start date/time and end date/time (Eastern Time).

- Physical Mailing Address
- Specification of which giveaway you are entering

All entries must be received before the end of the entry period.

Unless otherwise stated, one (1) entry per person. Multiple entries may be disqualified.
